- 2) The purpose of the Scheme
To amend the approved detailed Town Planning Scheme No. 229 published in P.O. No. 1263 dated 29.4.43. by changing the Zoning of the land marked A & B on the attached plan from its original zoning as Public Open Space into the following.
 - (a) The site marked A of an area of approx. 2000 sq.m. shall be zoned to be a site for a Public School.
 - (b) The site marked B of an area of approx. 6000 sq.m. shall be zoned as Public Open Space.
- 3) Special Conditions
 - (a) Parcel B. shall be a Play-Ground and shall be exclusively used for the school on Plot A.
 - (b) No buildings or out buildings or any other construction shall be ganted on plot B other than for the use of the school on Plot A. All such buildings shall be subject to the special approval of the District Commission.
- 4) All other provisions of the approved detailed Town Planning Scheme No. 229 shall fully apply.
