

Scheme No. 177
 Modification No. 1 of 1945
 of Detailed Scheme C-D Modification 1945.

Citation. 1) This Scheme may be cited as Scheme No. 177 Modification No. 1 of 1945 of Detailed Scheme C-D Modification 1945 and shall be read as one with the Detailed Scheme C-D Modification 1945 herein-after referred to as the principal scheme.

Modification 2) of the principal Scheme. The principal scheme shall be modified by including within the area thereof the area of parcels Nos. 88, 89, 90, 91, 92, 93, 94, 95, 96, 97, 98, 105, 106, 107, 108, 109, 110, 111, 112, 113, 114, 115, 116, 117, 118, 119, 120, 121, 122, 123, 124, 125, 126, 127, 128, 129, 130, 131, 132, 133, 134, 135, 136, 137, part of parcel No. 2 and part of parcel No. 138 of Registration Block No. 6206, which parcels (hereinafter referred to as the additional area) are within the Town Planning Area of Tel-Aviv, the boundaries of which Town Planning Area were published in Gazette No. 1467 of January 10th, 1946.

Object of the Scheme 2) The object of the Scheme is the allocation of the additional area as a public open space as shown on the attached plan coloured green, except parcel No. 137, which is dedicated for a residential zone as shown on the attached plan coloured yellow. The area of the public open space shall be added to the area of the public open space of the principal Scheme as shown on the map of the principal Scheme allotted for the purpose of a Municipal Park.

Regulations. 4) The provisions of this Scheme shall be in addition to and not in derogation of the provisions of the principal Scheme. Provided that in the case of any contradiction, or inconsistency between the provisions of the principal Scheme and the provisions of this Scheme, the provisions of this Scheme shall prevail.

Relation to previous Schemes 5) Any provision in any Scheme relating to the additional area shall cease to be in force as from the date of the authority to put into force this Scheme.
