TEL-AVIV TOWN PLANNING SCHEME NO. 61 (MODIFICATION) 1944.
DETAILED SCHEME FOR BLOCK NO. 6214.
 (Part of Scheme No. 58-Geddes)
 (Amendment) 1938

1. This Scheme may be cited as the Tel-Aviv Town Planning Scheme No. 61 (Modification) 1944 and shall be read as one with the Tel-Aviv Town Planning Scheme No. 61, 1940, hereinafter referred to as the principal Scheme.
2. The principal Scheme shall be modified by-
 - (a) the cancellation of the boundaries described therein and the substitution of the following boundaries therefor:- "Boundaries of the Scheme:-
 - North: Blocks 6212, 6957
 - East : Parcels 21, 147, 184, 276 of block 6214
Blocks 6213, 6216
 - South: Blocks 6215, 6954.
 - West : Blocks 6955, 6956.
 - (b) the alteration of the form and boundaries of the public open space designated therein and located in parcels 5, 9, 100 and 289 in Block 6214 into the form and boundaries designated in the plan annexed to the Scheme and which forms part thereof.
